ARTICLES OF INCORPORATION

0F

S.T.C. ENTERPRISES, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, each of whom is a natural person and a citizen of the United States of America and the State of Idaho, of the age of twenty-one years and upwards, desiring to form a corporation under the laws of the State of Idaho, do hereby adopt these Articles of Incorporation and execute the same in triplicate:

ARTICLE I.

The name of this corporation is S.T.C. ENTERPRISES, INC.

ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE III.

The location and post office address of the registered office of this corporation in the State of Idaho is Moscow, Idaho.

ARTICLE IV.

This corporation is authorized to issue one class shares of capital stock which shall be designated as common stock.

The total number of common stock this corporation shall be authorized to issue is two thousand (2000) shares.

The par value of each of the shares of common stock shall be Fifty Dollars (\$50.00).

The aggregate par value of the shares of the corporation shall be One Hundred Thousand Dollars (\$100,000.00).

ARTICLE V.

The objects and purposes for which this corporation is formed are and shall be:

To carry on and conduct a general construction and contracting business, including, but not limited to, the construction and sale of buildings.

To own, acquire, hold, sell, lease and otherwise dispose of real property and structures located thereon.

To purchase, subscribed for or otherwise acquire and own, hold, use, sell, assign, transfer, mortgage, pledge, exchange or otherwise dispose of real and personal property of every kind and description, including shares of stock, bonds, debentures, notes, evidences of indebtedness and other securities, contracts or obligations of any corporation or corporations, association or associations, domestic or foreign, and to pay therefor in whole or in part, in cash or by exchange therefor of stocks, bonds, or other evidences of indebtedness, or other securities, contracts or obligations, to receive, collect and dispose of the interest, dividends and income arising from such property and to exercise in respect thereof all the rights, powers and privileges of ownership, including all voting powers of any stocks so owned.

To aid, either by loans or by guaranty of securities, or in any other manner, persons, and to do any acts designed to protect, preserve, improve or enhance the value of any property at any time held or controlled by this corporation or in which it may be interested;

To enter into, make, perform and carry out contracts of any

kind for any lawful purpose of any person, firms, associations or corporations;

To purchase, acquire, lease, own, and enjoy any and all other property, real or personal, which may be reasonably necessary for carrying on the business of the corporation;

To engage in all businesses and to perform all acts permitted to corporations organized under the laws of the State of Idaho, whether or not such business or acts be specifically or impliedly enumerated in the foregoing clauses of this Article V.

And, in general, to carry on any lawful business whatsoever in connection with the foregoing, or which is calculated, directly or indirectly, to promote the interest of the corporation or to enhance the value of its properties and to have and exercise all the rights, powers and privileges now or hereafter conferred by the laws of the State of Idaho relating to corporations and any and all other acts amendatory thereof and supplemental thereto.

The purposes specified in this article shall be construed both as purposes and powers and shall be in no wise limited or restricted by reference to, or inference from, the terms of any other paragraph or clause in this or any other article, but the purposes and powers specified in each of the paragraphs and clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in anymanner the meaning or general terms and purposes or the general powers of the corporation; nor shall the expression of one thing be deemed to exclude another, although it be in like nature.

ARTICLE VI.

This corporation shall have power and authority to buy its own stock and to hold the same as treasury stock and to sell or otherwise dispose of the same.

ARTICLE VII.
