ARTICLES OF INCORPORATION OF

AMERICAN MUSTANG FOUNDATION/ELMORE COUNTY CHAPTER, INC.

A NON PROFIT CORPORATION

The undersigned, in order to form a non profit corporation pursuant to Idaho Non Profit Corporation Act, as contained in Chapter 3, Title 30, Idaho Code, do hereby adopt the following articles of incorporation, to wit:

I

NAME

The name of this corporation shall be American Mustang Foundation/Elmore County Chapter, Inc. There shall be no capital stock issued to officers or members. This corporation shall hereinafter be referred to as AMF/ECC.

II

DURATION

The duration of this corporation shall be on-going subject to the conditions for disillusionment as provided for in the By-Laws.

III

PURPOSES

This corporation is formed for the following charitable dedicated to the preservation, protection, purposes: promotion of legal utilization of the wild horse and burro, as established by the Wild Horse and Burro Act of 1971, and as amended in 1973; to promote ethical standards for the care and handling of wild horses and burros and the use of proper facilities for their care and handling; to educate others concerning wild horses and burros, their rehabilitation and habitat; to aid in the survival of wild horses and burros throughout established wild horse and burro resource management areas established by the Wild Horse and Burro Act of 1971 and as amended in 1973. This organization shall help collect, record and preserve the pedigrees of the American Mustang, publish a Stud Book and registry, and stimulate and regulate within the AMF any and all other matters such as may pertain to the history,

breeding, exhibition, publicity, sale, racing or improvement of wild horse and burros, hereinafter referred to as American Mustangs.

IV

MEMBERSHIPS

Section 1. Anyone who supports the purposes and By-Laws of the corporation may apply for membership. To become a member of the corporation membership dues must be paid as specified in the By-Laws. Each membership must be renewed annually by the payment of dues or membership fee. Membership in the corporation shall be evidenced by a membership card.

Section 2. Each membership of the corporation may be entitled to vote, as provided in the By-Laws.

Section 3. There shall be no discrimination in membership based on race, sex, color, creed, religion or national origin.

REGISTERED OFFICE

The street address of the initial registered office of the corporation shall be Canyon Creek Road, Mountain Home, Idaho 83647. The mailing address of the initial registered office of the corporation shall be P.O. Box 104, Mountain Home, Idaho 83647. The name of the registered agent at the above address shall be Ellen Coney.

VI

GOVERNING BODY

Section 1. The governing body of this corporation consists of a board of four directors and four officers (President, Vice President, Secretary, and Treasurer), who shall be elected and serve as provided herein and in the By-Laws(President has no vote except to break a tie). The number of directors may be changed from time to time as prescribed by the By-Laws.
