The following amendment of the Articles of Incorporation was adopted by the members of the corporation on the 22nd day of January, 1978, in the manner prescribed by the law of the State of Idaho and the Articles of Incorporation of the Twin Falls Reformed Church, Inc. Publication has been made as required by law and a copy attached hereto.

ARTICLE VI A

The members of this corporation have no property rights in the assets of the corporation, and upon the termination of the membership they shall be entitled to no interest in the assets and property of the church. In the event of the termination and dissolution of the corporation, the assets and property of the corporation shall be vastal in the classis of which the church is a member, Reformed Church in America.


