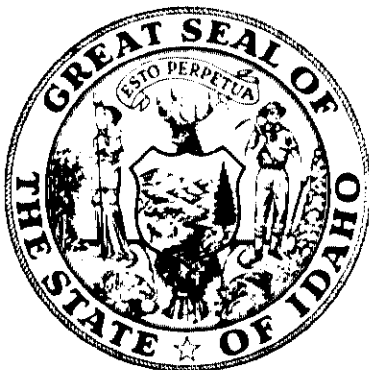

ARTICLES OF INCORPORATION
OF
H & H INVESTMENTS, INC.
an Idaho Corporation

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following ARTICLES OF INCORPORATION for such corporation:

ARTICLE I

The name of the corporation is: H & H INVESTMENTS, INC.

ARTICLE II

The period of the corporation's duration is perpetual.

ARTICLE III

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is TEN THOUSAND SHARES (10,000), Class "A" common stock and TEN THOUSAND SHARES (10,000) Class "B" common stock, each with a ONE DOLLAR (\$1.00) par value. Both classes of stock to have identical rights.

ARTICLE V

The address of the initial registered office of the corporation is 9765 Easy Street, Hayden Lake, Idaho 83835, and the name of the initial registered agent at such address is JAMES M. ENGLISH.

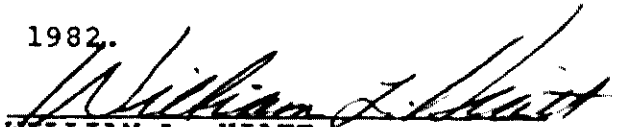
