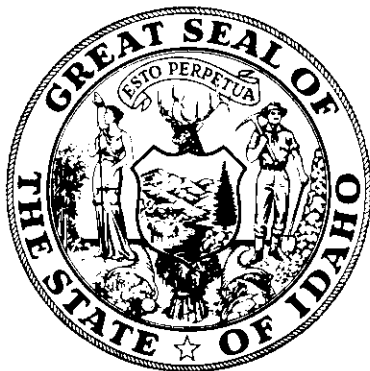

## ARTICLES OF INCORPORATION

### ARTICLE I.

The name of the corporation is Jolie Interior Designers, Inc.

### ARTICLE II.

The purpose of the corporation is to engage in any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act and also the following purposes:

To carry on and conduct in all its branches and departments, its principal or agent, the business of retail or wholesale merchants of furniture, fixtures, interior design, household appliances, household furnishings, office furnishings, commercial furnishings of every type and character at all business incidental or in any way connected with interior design and decoration.

To establish, purchase, lease as lessee or otherwise acquire, own, operate, and maintain, sell, mortgage, deed and trust, lease as lessor, and otherwise dispose of retail stores or departments therein; to buy, sell, trade, manufacture, deal in and with goods, wears, and merchandise of every kind and nature and to carry on such business as wholesalers, retailers, importers, and exporters; to acquire all such merchandise, supplies, materials, and other

articles as shall be necessary or incidental to such business; and to have any and all powers to carry out the purposes above set forth as fully as natural persons, whether as principals, agents, trustees, or otherwise.

ARTICLE III.

The period of duration of the corporation is perpetual.

ARTICLE IV.

The address of the corporation's initial registered office in the State of Idaho is 926 North Cleveland, City of Moscow, County of Latah. The name of the corporation's initial registered agent is D. Joan Bauer.

ARTICLE V.

The total authorized number of par value shares of stock is 500. The aggregate par value of the total authorized number of par value shares is <sup>FIFTY</sup>THOUSAND dollars (\$50,000.00). The par value of each share of stock is in the sum of \$100.00. All the stock will be common stock.

ARTICLE VI.

The preemptive rights will be defined by Idaho Code 30-1-26, as amended.


