

ARTICLES OF INCORPORATION
of the

Snow Storm, Mining Company,

Know all men by these presents: That we, the undersigned citizens of the United States and residents and citizens of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho. And we hereby certify:

First,- That the name of said corporation shall be the "Snow Storm Mining Company"

Second- That the purposes for which it is formed, are, To own, buy, sell, locate, and dispose of mines and all things pertaining thereto, and to develop, work and handle the same and do all things necessary and incident thereto, including buying, selling, milling and handling ore, running a boarding house and doing all other lawful things in connection with, concerning or about the doing of said things or any thereof, in the State of Idaho or elsewhere.

Third-, That the place where the principal business of said corporation is to be transacted is Mullan, Shoshone County, Idaho.

Fourth-, That the term for which said corporation is to exist, is, Fifty years from and after the date of its incorporation.

Fifth-, That the number of Directors of said Corporation shall be five, and the names and residence of the directors who are appointed for the first year, and to serve until the election and qualification of their successors are as follows:

Sixth-, That the amount of the Capital Stock of said corporation is One Hundred Thousand Dollars, and the number of shares into which it is divided is ~~One Hundred thousand~~ *One million*, of the par value of ten cents each.

That the amount of said capital stock which has been actual-ly subscribed, is One Hundred Thousand Dollars, and the following are the names by whom the same has been subscribed and the amount by each of them:

And that all of said stock is fully paid up and non-assessable.

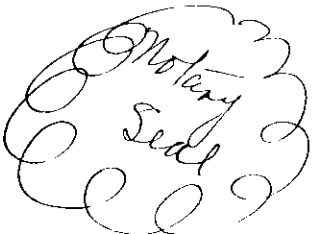
