ARTICLES OF AMENDMENT
OF
ARTICLES OF INCORPORATION

John W. Hewitt and Lester L. Schmidt do hereby certify that they are the President and Secretary, respectively, of Syringa, Inc. an Idaho corporation organized and existing under and by virtue of the laws of the State of Idaho. By agreement of the Stockholder in lieu of a special meeting of the Stockholder of Syringa, Inc. the Articles of Incorporation of Syringa, Inc. were amended to change the name of the corporation from "Syringa, Inc." to "Provident Service Corporation" by amending Article I of the Articles of Incorporation to read as follows:

ARTICLE I

The name of the corporation is and shall
be Provident Service Corporation

The Stockholder of the corporation executed the agreement in lieu of a meeting and adopted the above amendment on the 12 day of May, 1985.

By such agreement in lieu of meeting, the undersigned President and Secretary were further instructed to cause Articles of Amendment to be prepared, sworn to and filed as required by law to accomplish the amendment of the Articles in accordance with the agreement of the Stockholder.

There are 50,000 shares outstanding and entitled to vote and all shares were voted by the Stockholder of this corporation in favor of the amendment.

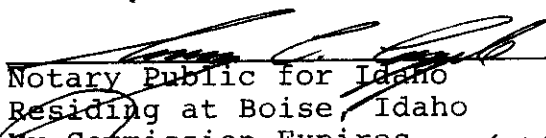
