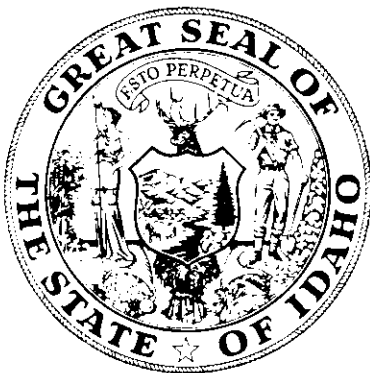

ARTICLES OF MERGER

NORTHWEST AGGREGATES OF IDAHO, INC.

SEUBERT EXCAVATORS, INC.

TO THE SECRETARY OF STATE OF THE STATE OF IDAHO:

The undersigned, Seubert Excavators, Inc., an Idaho corporation, hereinafter designated the surviving corporation, pursuant to Section 30-1-75 of the Idaho Code, hereby executes in duplicate the following Articles of Merger of Northwest Aggregates of Idaho, Inc., an Idaho corporation, and a one hundred percent owned subsidiary of the undersigned, into the undersigned surviving corporation:

1.. The Plan of Merger of said subsidiary corporation approved by resolution of the board of directors of the surviving corporation on June 17, 1985, in accordance with the provisions of Section 30-1-75 of the Idaho Code, is as follows:

1. The name of the subsidiary corporation is NORTHWEST AGGREGATES OF IDAHO, INC., an Idaho corporation.
2. SEUBERT EXCAVATORS, INC., an Idaho corporation, owns one hundred percent of the issued and outstanding common capital stock of the subsidiary, there being only one class of stock, and will be the surviving corporation.
3. The shares of the subsidiary corporation owned by the surviving corporation shall be surrendered to the subsidiary corporation for cancellation in consideration of the transfer of the assets of the subsidiary to the surviving corporation and its assumption of the liabilities and obligation of the subsidiary corporation.

2. There are 997 shares of the common capital stock of the subsidiary issued and outstanding, there being only one class of stock. All of said shares are owned by the surviving corporation.

3. The date of the mailing to the sole shareholder of the subsidiary corporation of a copy of the Plan of Merger hereinabove set forth was June 17, 1985.
