
### CERTIFICATE OF AMENDMENT OF

1. The name of the corporation prior to amendment is Northwest Plumbing, Inc.

2. That at the annual stockholder's meeting held April 12, 1994 the undersigned, as sole stockholder of the corporation, adopted a resolution to amend Article I of the corporation's Articles of Incorporation as follows:


The name of this Corporation shall be "Northwest Plumbing and Heating, Inc." and its existence shall be perpetual.


