

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is RICHTER'S, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the Corporation is organized are: To own and operate a bar and cafe and any and all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 100,000 with a \$1.00 par value.

FIFTH: The transfer of the shares of the Corporation are restricted and such restriction shall be noted on the back of each outstanding certificate as follows:

"Any sale, assignment, transfer, pledge or other disposition of the shares of stock represented by this certificate is restricted by, and subject to the terms and provisions of a Shareholders' Agreement dated as of the day of ______, 19___. A copy of said Agreement is on file with the Secretary of the Corporation. By acceptance of this certificate, the holder hereof agrees to be bound by the terms of said Agreement."

SIXTH: The address of the initial registered office of the Corporation is Richter's Mahogany Bar, Main Street, P. O. Box 32, Yellowpine, Idaho 83677, and the name of its initial registered agent at such address is Thomas A. Richter.
