Articles of Incorporation  
of Idaho Woodcarvers, Inc.

ARTICLE I

The name of this Organization shall be Idaho Woodcarvers, Inc.

ARTICLE II

This Organization is a non-profit organization and existing under the laws of the State of Idaho.

ARTICLE III

This Organization shall be perpetual.

ARTICLE IV

The aim and object of this Organization is to encourage and promote the craft and art of woodcarving.
