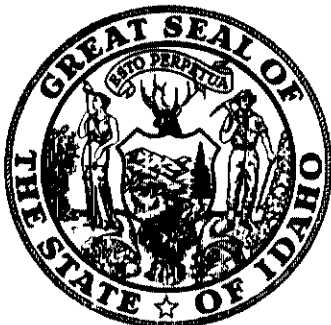
CERTIFICATE OF INCORPORATION OF

OF
TREASURE VALLEY SPORT AVIATION, INC.**

The undersigned, acting as incorporator under the Idaho Business Corporation Act, adopts the following articles of incorporation:

**ARTICLE I.
NAME OF THE CORPORATION**

The name of the corporation is TREASURE VALLEY SPORT AVIATION, INC. ("Corporation").

**ARTICLE II.
DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III.


