ARTICLES OF INCORPORATION
OF
MAJESTIC MOUNTAIN BAPTIST CHURCH, INC.

WE, the undersigned, incorporate the Majestic Mountain Baptist Church with the following Articles under the laws of the State of Idaho.

ARTICLE I

NAME: The name of the corporation is MAJESTIC MOUNTAIN BAPTIST CHURCH, INC.

ARTICLE II

NON-PROFIT: The corporation is a non-profit corporation. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V.

ARTICLE III

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section

501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of trustees shall determine.

ARTICLE IV

DURATION: The existence of this corporation is perpetual.

ARTICLE V

PURPOSE: The corporation is organized for religious purposes, including worship and religious education. In addition, the corporation may hold, own, mortgage, dispose of and invest its funds in real and personal property for the benefit of the corporation.

ARTICLE VI

REGISTERED OFFICE: The registered office of the corporation is 108 Wiloughby Drive, Pierce, Idaho 83546; the corporation's mailing address is P. O. Box 186, Pierce, Idaho 83546.

ARTICLE VII

REGISTERED AGENT: The corporation's registered agent at such address is its Pastor, Gary Snyder.

ARTICLE VIII

DIRECTORS; INCORPORATORS: The Trustees and Pastor of the Church will fulfill the functions of the Board of Directors, referred to as the "Board" of the corporation. The three Trustees currently holding office and the present Pastor of the church are to serve as the initial Board of Directors. They are also the incorporators. ARTICLE IX

MEETINGS: Meetings of the Board shall be scheduled by agreement of the Board.

ARTICLE X

QUORUMS OF MEMBERS: Thirty per cent (30%) of the members (as defined in the Bylaws) shall constitute a quorum for all votes, including the election of officers, with the two exceptions below. Fifty per cent (50%) of the members shall constitute a quorum for the decision to employ a pastor. There shall be no specific quorum necessary for the election of new members; whatever number of members are present at the worship service at which the vote on new members is taken constitutes a sufficient quorum.
