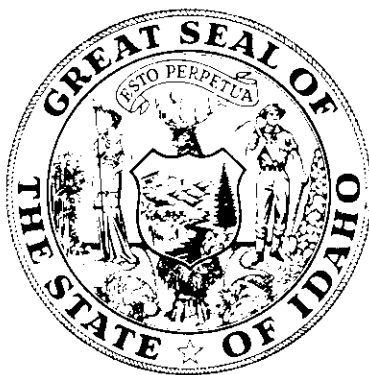

## ARTICLES OF DISSOLUTION

To the Secretary of State of Idaho.

Pursuant to the provisions of Idaho Code §30-18-3, §30-1-87, §30-1-92 and §30-1-93, the undersigned corporation adopts the following articles of dissolution for the purpose of dissolving the corporation:


