

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- FIRST: The name of the corporation is McCALL GAS STATION, INC.
- SECOND: The period of its duration is perpetual.
- THIRD: The purpose or purposes for which the corporation is organized are: The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1000) shares of common stock, all without par value.
- FIFTH: The address of the initial registered office of the corporation is end of Lang Court, McCall, Idaho, and the name of its initial registered agent at such address is D. John Carey.


