ARTICLES OF AMENDMENT

TO THE

RESTATED ARTICLES OF ASSOCIATION

OF

UNION PACIFIC RAILROAD COMPANY

Pursuant to the provisions of Section 16-10-57 of the Utah Business Corporation Act, as amended (Title 16, Chapter 10, Section 57, Utah Code Annotated, 1953, as amended by Senate Bill No. 91, 39th Legislature, effective May 11, 1971), Union Pacific Railroad Company, a corporation of the State of Utah, hereby adopts the following Articles of Amendment to its Restated Articles of Association:

- (a) The name of the corporation is Union Pacific Railroad Company.
- (b) The following amendments to its Restated Articles of Association were adopted by the shareholders of the corporation in the manner provided by the Utah Business Corporation Act.

Amendment (1)

ARTICLE 2 is restated in its entirety to read:

"ARTICLE 2. Said corporation shall have perpetual existence."

Amendment (2)

A new article numbered ll is added, to read:

"ARTICLE 11. Any stockholder of the corporation who shall have followed the procedures specified in section 16-10-76 of the Utah Business Corporation Act in connection with the stockholders meeting held to approve an Agreement of Merger and Plan of Reorganization dated May 11, 1971 among the corporation, UPCO Corporation, a Utah corporation, and Union Pacific Corporation, a Utah corporation, shall be entitled to exercise the rights specified in said section notwithstanding that this Article 11 shall not have been in effect prior to such stockholders meeting."

(c) The date of the adoption of said amendments by the shareholders of the corporation was June 24, 1971.

- (d) The number of shares of the corporation outstanding at the time of such adoption was 29,929,235; and the number of shares entitled to vote thereon was 29,929,235.
- (e) The number of shares voted for such amendments was 28/99/77; and the number of shares voted against such amendments was 59/62.
