We, the undersigned, desiring to form a non-profit corporation under the statutes of the State of Idaho, do hereby make, subscribe and acknowledge as follows:

ARTICLE ONE

NAME

The name of the corporation is SILVER LEAF REBEKAH LODGE No.27, I.O.O.F., Inc.

ARTICLE TWO

That the purposes for which this Corporation is formed are to lease, purchase, receive, hold, sell, convey, and mortgage such real or personal property as such lodge or corporation may acquire, own, or use for the purposes of such corporation or lodge, according to the Constitution, bylaws, rules and regulations of the Independent Order of Odd Fellows and the Laws of the State of Idaho. To borrow money, to be evidenced by promissory notes, bonds, or other lawful obligations, either secured or unsecured, by the hypothecation of any or all of its real, personal or mixed property, and to that end to enter into such lawful contracts as may be necessary to raise money to build or complete a building, to be occupied in whole or in part, as a hall to be used for the purposes of said lodge.
