ARTICLES OF INCORPORATION  
OF THE

KNOW ALL MEN BY THESE PRESENTS, that We, the undersigned, all of whom are bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under and by virtue of the laws of the State of Idaho; that we do hereby certify as follows:

FIRST: That the name of this Corporation shall be,  
PANIDA INVESTMENT COMPANY

SECOND: That the purposes for which this Corporation is formed shall be:

- (1) To purchase, own, sell, convey, lease, mortgage, hypothecate, or otherwise incumber and contract with reference to real estate.
- (2) To purchase, own, sell, convey, mortgage, incumber, contract with reference to and to generally deal in personal property.
- (3) To represent by agency, local or otherwise, properly authorized insurance companies operating within the State of Idaho, and to generally act as authorized agent of any firm, co-partnership, individual or Corporation, lawfully authorized to do business within the State of Idaho.
- (4) To purchase, own, sell and convey, contract with reference to stocks, bonds, real estate mortgages, chattel mortgages, conditional sales contracts, escrows and equities.
- (5) To borrow or loan money and to generally do each and all acts necessary or proper to do for the purpose of carrying out the objects for which this Corporation is formed.

KNOW ALL MEN BY THESE PRESENTS that we, F. W. Lampkin, E. B. Aldrich, Lee D. Drake and J. S. Harvey, all being residents of the State of Oregon and each and all being citizens of the United States, do hereby associate ourselves for the purpose of forming a private corporation under and by virtue of the general incorporation laws of the State of Oregon and do hereby adopt the following Articles of Incorporation:

ARTICLE I.

The name assumed by this corporation and by which it shall be known and under which it shall act shall be

IDAHO TIMES PUBLISHING CO.

ARTICLE II.

The duration of this corporation shall be unlimited.

ARTICLE III.

The enterprise, business, pursuit and occupation for which this corporation is organized and in which it purposes to engage is:

To acquire, print, publish, conduct and circulate or otherwise deal with any newspaper or newspapers or other publication and generally to carry on the business of newspaper proprietors and general publishers; to carry on, if and when it shall deem desirable the trade or business as general printers, book sellers, book binders, stationers, photographers, photographic printers, stereotypers, electrotypers, lithographers and advertising agents to publish, distribute and broadcast news of the day, advertising matter and other information in which the public has an interest, by

THIRD: That the principal place of business of this Corporation shall be Coeur d'Alene, Kootenai County, Idaho.

FOURTH: The term for which this Corporation is to exist shall be 50 years from and after the date of its incorporation.

FIFTH: That the number of its Directors shall be three, a majority of whom must be citizens and actual bona fide residents within the State of Idaho, and the names and addresses of those who are appointed for the first year are as follows:

To issue bonds, debentures or obligations of and in the credit of this corporation from time to time, for any of the objects or purposes of the corporation, and to secure the same by mortgage, pledge, deed of trust, or otherwise.
