ARTICLES OF INCORPORATION

OF

JET PAVING, INC.

The undersigned, acting as the incorporator of a corporation under the provisions of the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is JET PAVING, INC.

SECOND: The period of its existence is perpetual.

THIRD: The purposes for which the corporation is organized shall be the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

FOURTH: The corporation shall have authority to issue 100,000 shares of capital stock having no par value. All of such shares shall be voting common stock having full rights of participation in the profits, losses and assets of the corporation.

FIFTH: The address of the initial registered office of the corporation is 191 W. Roseberry Road, P.O. Box 728, Donnelly, Idaho 83615 and the name of its initial registered agent at such address is Terry F. Gestrin.
