KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned John J. Duman and Cara M. Duman, each being a natural person of full age, and a citizen of the United States of America, have voluntarily and do hereby associate ourselves together for the purpose of forming a corporation under the Idaho Business Corporation Act, and we do hereby certify, declare and adopt the following Articles of Incorporation:

I.

The name of the corporation shall be Truck and Auto Paint Shoppe, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The location of the registered office of this corporation shall be Cottonwood, Idaho and the address of the registered office of the corporation shall be P.O. Box 62, Cottonwood, Idaho 83522 and the registered agent at this address is John J. Duman.

VI.




