RECITALS

WHEREAS, the Company is a limited liability company duly organized and existing under the laws of the State of Arizona.

WHEREAS, the Company wishes to change its domicile and entity jurisdiction from Arizona to Idaho by domestication on the terms set forth more fully in the Plan of Domestication;

WHEREAS, domestication of a company to Idaho is permitted by Idaho Code Title 30, Chapter 22; and

WHEREAS, the Members in the Company, by their signature, have approved the Plan of Domestication and approve this Statement of Domestication.

NOW THEREFORE, the Company agrees, as of February 1, 2022, as follows:

- 1. Conversion and Domestication. Upon filing, the Company shall convert from an Arizona company to an Idaho company by domesticating to Idaho pursuant to Idaho Code § 30-22-502. Following domestication the Company shall be governed by the laws of the State of Idaho. The change in jurisdiction of the Company to Idaho shall herein be referred to as the "Domestication."
- 2. Effective Date. The Domestication shall be effective upon (a) the filing of a Statement of Domestication with the Secretary of State of the State of Idaho; (b) the filing of a Certificate of Organization for Ringe Properties, LLC with the Idaho Secretary of State; and (c) the filing of a Statement of Domestication with the Secretary of State of the Arizona, which filings shall be made as soon as practicable after all required approvals have been obtained. The time of such effectiveness shall herein be referred to as the "Effective Date."
- 3. Interest Holders. On the Effective Date, each membership interest in the Arizona company shall be the same ownership interest in the Idaho company.
- 4. Approval. The Plan of Domestication and this Statement of Domestication have been approved by the owners of the Company and the Managers of the Company in accordance with the laws of the State of Arizona.

- 5. Public Record. The Company's organic public record is attached as Exhibit A.
- 6. Registered Agent. The Company's registered agent shall be:
