Pursuant to the provisions of Section 30-326 of the Idaho Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

 $\overline{\text{FIRST}}$: The name of the corporation is SALMON SENIOR CITIZENS NUTRITION SITE ASSOCIATION, INC.

SECOND: The following amendments to the Articles of Incorporation were adopted by the members of the corporation on <u>Grand 22</u>, 1988, in the manner prescribed by the Idaho Non-Profit Corporation Act:

ARTICLE IX

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

This organization is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under Section 50l(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by an organization contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

The above amendment is in addition to the original Articles of Incorporation, and does not alter any provision of the original Articles of Incorporation. Said amendment was adopted on 2. 1988 at a meeting of the members of the corporation, a quorum was present at such meeting and that said amendment received at least a majority of the votes of members present at said meeting in person or by proxy were entitled to cast.
