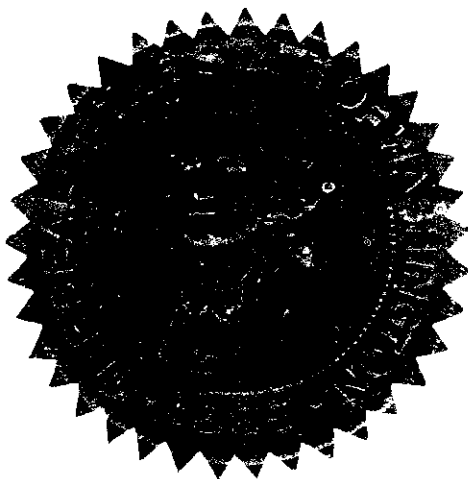

ARTICLES OF INCORPORATION

OF

ELECTRIC NEON SIGN CO., INC.

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, JAMES J. COSHOW, HAROLD B. THOMPSON, and PAUL F. SCHEDLER, all of whom are of full age, and citizens of the United States, hereby sign and acknowledge, in triplicate originals, the following

ARTICLES OF INCORPORATION

I.

The name of this corporation shall be "ELECTRIC NEON SIGN CO., INC."

II.

The purpose of this corporation shall be to engage in the manufacturing, distributing, and marketing, both wholesale and retail, of electric neon signs; to buy and sell or maintain all forms of property, both real and personal, and to purchase and lease from others, and otherwise acquire, sell, convey, transfer, or otherwise dispose of, mortgage, or encumber such real or personal property as we may have an interest in, and to engage in any and all business that may be decided upon from time to time by the Directors of this corporation.

III.

The duration of this corporation shall be perpetual.

IV.

The location and postoffice address of the registered office of this corporation in this State shall be 623 South Blake, Spokane, Washington.

V.

The total authorized number of par value shares of this corporation shall be Five Thousand (5,000) and the par value of each share shall be Ten (\$10.00) Dollars.

VI.

The amount of paid in capital with which the corporation shall begin business shall be One Thousand Seven Hundred Fifty and no/100 (\$1,750.00) Dollars.
