ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being citizens of the United States of America, and being persons of full legal age, have this day voluntarily formed a domestic corporation under and pursuant to the laws of the State of Idaho, and do hereby certify as follows:

FIRST: The name of this corporation shall be CAPITOL SECURITY SERVICES, INC.

SECOND: The purposes for which this corporation is formed are as follows:

A. To engage in any lawful business activity for which corporations may be organized under the laws of the State of Idaho including, but not limited to, providing security services.

B. To do and perform any act, matter or anything necessary, proper or convenient for the accomplishment of the purpose of the corporation.

THIRD: The period of existence and duration of the life of this corporation shall be perpetual.

FOURTH: The location and post office address of the registered office of the corporation in the State of Idaho shall be 316 Garland St., Nampa, Idaho, 83686.

FIFTH: This corporation is authorized to issue one class of shares of capital stock to be designated as "common" stock. The total number of common shares which this corporation shall be authorized to issue is ONE THOUSAND (1,000) shares, said common shares having a par value of \$10.00 per share.

SIXTH: The name and post office address of the incorporators of this corporation are as follows:




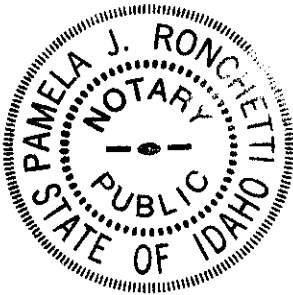
