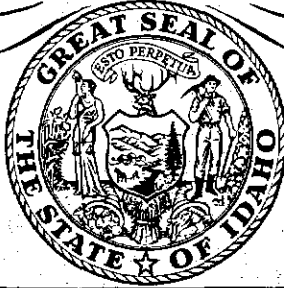

ARTICLES OF AMENDMENT

OF

GEM STATE MANUFACTURING CO., INC.

KNOW ALL MEN BY THESE PRESENTS, That we the undersigned, J. STEVE CHOBORDA and HELEN CHOBORDA, being President and Secretary, respectively of GEM STATE MANUFACTURING CO., INC. do hereby certify as follows:

That a special meeting of the Stockholders was held January 20, 1967 at the office of the Corporation, 420 Marden St., Boise, Idaho, at which meeting all of the Stockholders were present. At said meeting a resolution was regularly proposed and adopted by unanimous vote of said Stockholders amending the Articles of Incorporation as follows:

Article VIII is deleted and replaced with:

"The Corporation shall have a total authorized capital stock of 100,000 shares of \$1.00 par stock with a total capitalization of \$100,000.00 and which shall be, when issued, non-assessable."


