

In compliance with the requirements of the Idaho Nonprofit Corporation Act, Section 30-3-1, et seq., Idaho Code, the undersigned, all of whom are residents of the State of Idaho, and all of whom are of full age, have this day voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

ARTICLE I

The name of this corporation is IDAHO BOARD SPORTS ASSOCIATION, INC., hereafter referred to as the "Association."

ARTICLE II

The purpose for which this corporation is organized is for the transaction of any lawful activity, and more specifically including, but not limited to, the following: To provide a safe environment for skate and snow boarders to develop their skills and athletic abilities; to coordinate skate and snow boarding activities with local organizations and governmental agencies; and to establish community interest in, and development of, skate and snow boarding facilities and to sponsor competitive events.

ARTICLE III

The affairs of this Association shall be managed by a board of four directors. The number of directors may be changed by amendment of the Bylaws of the Association. The names and addresses of the persons who are to act in the capacity of directors until the selection of their successors are:

#### ARTICLE VII


Upon dissolution of the Association, other than incident to a merger or consolidation, the assets of the Association shall be dedicated to an appropriate public agency to be used for purposes
