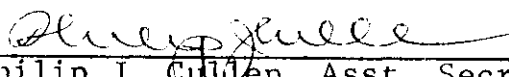
That the Articles of Incorporation of Seaboard Finance Company of Pocatello be amended by changing the corporate name to read as follows:
