

1 ARTICLES OF INCORPORATION OF YOLANDE MINING COMPANY.

3 KNOW ALL MEN BY THESE PRESENTS, that the undersigned,  
4 *J. L. Mayo* H.W. Morse, Thomas L. Greenough, Joseph Carson, W.H. Myers and  
5 P.H. Remshaw, hereby associate themselves together for the purpose  
6 of forming a corporation under the provisions of the laws of the  
7 State of Idaho, and for such purposes state,

8 -I-

9 That the name of the corporation shall be "The Yo-  
10 lande Mining Company."

11 -II-

12 That the purpose for which this corporation is formed  
13 is for mining and operating mines and mining claims within said  
14 State of Idaho, and particularly within said Shoshone County in  
15 said State. Also for the purpose of buying, selling, locating, bond-  
16 ing, contracting for, leasing and operating mines and mining claims  
17 together with the necessary appliances connected therewith for  
18 the purpose of working, operating and developing mining claims;  
19 the purchase, lease, construction, owning, operating and con-  
20 trolling tram-ways, electric plants and power, water-power, machin-  
21 ery, mills, smelters, concentrators, power plants, electric lines,  
22 water rights and ditches and each and every thing incident and  
23 necessary to the ownership, enjoyment and use of the aforementioned
