ARTICLES OF INCORPORATION SECRETARY OF STATE

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, being natural persons of full age and all citizens of the United States, in order to form a corporation for the purposes hereinafter stated pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

- 1. Name. The name of the corporation is J & G, INC.
- 2. <u>Purposes</u>. The purposes of the corporation shall be:
 - 1. To manufacture, buy, sell, lease, trade, repair, alter and otherwise deal in motors, automobiles, trucks, cars, and other vehicles, their parts, accessories and related articles and generally to conduct an automobile dealership business in all its aspects, including the sale and marketing of all types of insurance, including but not limited to automobile insurance in all of its aspects such as public liability, property damage and comprehensive coverages. In carrying out these purposes, the corporation shall have all lawful powers now or hereafter conferred by the laws of the State of Idaho upon corporations generally.
 - 2. To buy, sell, mortgage, exchange, lease, let, hold for investment or otherwise, use and operate real estate of all kinds, improved or unimproved, and any right or interest therein. To purchase, or otherwise acquire, invest in, own, hold, use, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, trade, deal in and deal with any and all kinds of equipment and other personal property and otherwise acquire, invest in, own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, deal in, and deal with any and all articles or things.
 - 3. To manufacture, produce, buy, sell, trade and deal in any and all types and kinds of goods, machinery, products, merchandise and personal property of every class and description at wholesale or retail for and on the account of the corporation or as manufacturer, broker, factor, or agent for others.
 - 4. Without in any manner limiting any of the objects, purposes or powers of the corporation, the

business or purposes of said corporation shall be from time to time to do any one or more of all of the acts or things herein set forth.

- 5. The several subdivisions contained in this paragraph of purposes shall be construed as both purposes and powers and the enumeration thereof shall not be held to limit or restrict in any manner the general powers conferred on business corporations by the laws of the State of Idaho, all of which powers are hereby expressly claimed.
- 3. <u>Duration</u>. The duration of the corporation shall be perpetual.

- 4. Registered Office. The registered office of said corporation in the State of Idaho shall be located in Twin Falls, in the County of Twin Falls, and that the post office address of the registered office of said corporation in the State of Idaho is 601 Main Avenue East, P. O. Box 283, Twin Falls, Idaho 83301. The registered agent of the corporation is Gary R. Halverson, whose address is 749 May Drive, Twin Falls, Idaho 83301.
- 5. <u>Capital Stock</u>. The total authorized number of par value shares of the corporation is 500 shares of common stock with equal rights, and their aggregate par value shall be \$50,000.
- 6. <u>Incorporators</u>. The amount of capital stock of said corporation which has been actually subscribed is Three (3) shares, and the following are the names and post office addresses of each of the incorporators and initial directors and the number of shares subscribed by each.
