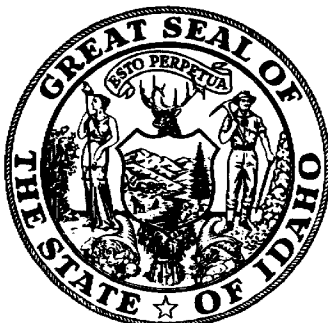

OF

The undersigned, desiring to act as a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

FIRST: The name of the Corporation is:

Idaho Hardwood, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The Purpose or purposes for which the corporation is organized is the transaction of any or all lawful businesses for which corporations may be incorporated under the Idaho Business Corporation Act, including the sales, service and placement of hardwood floors.

FOURTH: The total authorized stock of this corporation shall be divided into 300 shares of a single class, all of which shall be without nominal or par value.

FIFTH: There are no provisions denying preemptive rights.

SIXTH: There are no provisions for the regulation of the international affairs of the corporation.

SEVENTH: The address of the initial registered office of the corporation and the name of its initial registered agent at such address is:
