KNOW ALL MEN BY THESE PRESENTS: that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Nevada.

- 1. The name of the corporation is "B. J. CARNEY & COMPANY".
- 2. The principal office of the corporation is to be located at No. 139 North Virginia Street in the city of Reno, in the County of Washoe, in the State of Nevada. The corporation may maintain offices at Grinnell, Iowa, Spokane, Washington, and at such other place or places as may be authorized by the Board of Directors.
