

3 1. The present name of the corporation is Idaho-Oregon Onion Packers,  
4 Inc., however, pursuant to the hereinafter set forth amendment, the name of  
5 the corporation will be Sunrise Produce, Inc., effective August 20, 1984.

6 2. That the following amendment has been adopted to the Articles of  
7 Incorporation: In Article I of the Articles of Incorporation of Idaho-Oregon  
8 Onion Packers, Inc., the following has been deleted: "IDAHO-OREGON ONION  
9 PACKERS, INC." and the following has been substituted in place of said deleted  
10 material: "SUNRISE PRODUCE, INC.". That the effect of such amendment is to  
11 change the corporate name to Sunrise Produce, Inc.


12 3. That the above change to the Articles of Incorporation was adopted by  
13 the shareholders on August 8, 1984.


14 4. That the number of shares outstanding and entitled to vote on such an






