ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
COEUR D'ALENE PRESS, INC.

Pursuant to the provisions of Section 30-146 of the Business Corporation Act of Idaho, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is COEUR D'ALENE PRESS, INC.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on June 19, 1974, in the manner prescribed by the Business Corporation Act of Idaho:

1. Amending Article V to read as follows:

"The capital stock of this corporation shall consist of Two Thousand Five Hundred (2,500) shares of Common Stock, each of a par value of Ten Dollars (\$10.00). The aggregate par value of said shares is the sum of Twenty-Five Thousand Dollars (\$25,000.00). Each share shall be entitled to one vote."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 1,000; and the number of shares entitled to vote was 1,000.

FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon were as follows:

FIFTH: The number of shares voted for such amendment was 1,000; and the number of shares voted against such amendment was NONE.

SIXTH: The number of shares of each class entitled to vote thereon as a class voted for and against such amendment,

SEVENTH: The manner in which said amendment provides for an exchange or a reclassification or a cancellation of issued shares of said corporation is as follows: NO CHANGE

EIGHTH: The manner in which such amendment effects a change in the amount of stated capital of the corporation is as follows: Increases the stated capital from \$10,000.00 to \$25,000.00. The amount of stated capital as changed by said amendment is \$25,000.00.
