


CERTIFICATE OF INCORPORATION **OF**

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned being of full legal age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and hereby adopt Articles of Incorporation as follows:

The name of the corporation shall be ALPINE LUMBER SUPPLY, INC.

The period of duration of the corporation shall be perpetual.

III

The purpose of the corporation shall be the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

The corporation shall have the authority to issue Five Thousand (5,000) Shares of One Hundred (\$100) Dollars par value stock of a single class of voting common.
