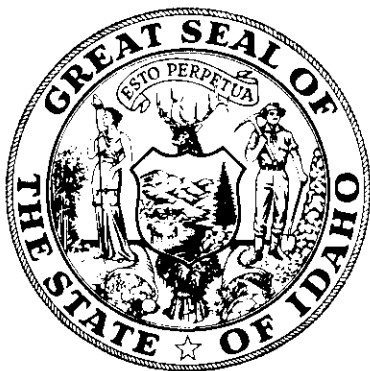

ARTICLES OF INCORPORATION FOR  
LEROY R. MISNER, P.A.

The undersigned being all natural persons of the age twenty-one (21), years or more, and acting as incorporators of a Corporation under the IDAHO CORPORATION ACT, adopt the following Articles of Incorporation.

I

The name of this Corporation shall be LEROY R. MISNER, P.A.

II

The terms of this Corporation shall be perpetual.

III

This shall be a professional association to engage in the business and practice of dentistry. And to engage in any other business not forbidden by law for professional associations.

IV

The name of the association registered agent shall be LeRoy R. Misner, D.D.S. The address of the initial registered agent is 2730 Kristen, Pocatello, Idaho, 83202.

V

The Corporation shall have the authority to issue twenty-thousand (20,000) shares of common stock at a par value of one dollar (\$1.00) per share, for an aggregate par value of twenty-thousand dollars (\$20,000).

All stocks shall be common stock with each share issued to be entitled to one vote at meetings of the stock holders of the Corporation.
