

ARTICLES OF MERGER



SECTION STATE

Pursuant to the provisions of Idaho Code §30-1-77, the undersigned domestic and foreign corporations have adopted the following Articles of Merger for the purpose of merging them into one of such corporations.

1. The names of the undersigned corporations in the states under the laws of which each is organized are:

C. W. Sales, Incorporated Idaho
C. W. Sales, Incorporated Washington

- 2. The laws of the state under which such foreign corporation is organized permit such merger;
- 3. The name of the surviving corporation is C. W. Sales, Incorporated, and it is to be governed by the laws of the State of Idaho;
- 4. The following plan of merger was approved by the sole shareholder of the undersigned domestic corporation on September 8, 1994, in the manner prescribed by statute, and was approved by the sole shareholder of the undersigned foreign corporation on September 8, 1994, in the manner prescribed by the laws of the state under which it is organized, as follows:
 - a. The merging corporation shall be merged into a surviving corporation;
 - b. The number of shares outstanding of C. W. Sales, Incorporated, a Washington corporation, is One Thousand (1,000) there is only one class of shares, and all of the outstanding shares voted approval of the merger;
 - c. The number of shares outstanding of C. W. Sales, Incorporated, an Idaho corporation, is One Thousand, there is only one class of shares, and all of the outstanding shares voted approval of the merger;
 - d. The outstanding shares of surviving corporation shall remain outstanding and are not affected by the merger;
 - e. Merging corporation shall from time to time, as and when requested by surviving corporation, execute and deliver all such documents and instruments and take all such action necessary or desirable to evidence or carry out this merger;

The effect of a merger is as prescribed by law;

The surviving corporation may be served with process in this state in any proceeding for the enforcement of any obligation of any domestic corporation which is a party to such merger and in any proceeding for the enforcement of the rights of a dissenting shareholder of any such a domestic corporation;

The Secretary of State of the State of Idaho is irrevocably appointed as the agent of surgery groups of surgery groups of the process of any such proceeding;

Surviving corporation shall promptly pay to dissenting shareholders of any such domestic corporation, the amount, if any, to which they shall be entitled under provisions of the Idaho Business Corporation Act and the Idaho Professional Service Corporation Act, with respect to the rights of descending shareholders.
