ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is SUNDANCE EQUIPMENT COMPANY.

SECOND: The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on the 20th day of October, 1983, in the manner prescribed by the Idaho Business Corporation Act:

The name of the corporation is amended to SUNDANCE LEASING COMPANY.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was two (2), both of which shares were entitled to vote thereon and both of which are of the same class.

FOURTH: The number of shares voted for such amendment was two (2). No shares voted against such amendment.

FIFTH: The manner in which any exchange, reclassification or cancellation of issued shares shall be effected is as follows:

Stock certificates bearing the name of "SUNDANCE LEASING COMPANY" shall be delivered to the corporation and exchanged for stock certificates representing the same number of shares bearing the amended name "SUNDANCE LEASING COMPANY."

SIXTH: The amendment does not effect a change in the amount of the stated capital of the corporation.
