ARTICLE XI

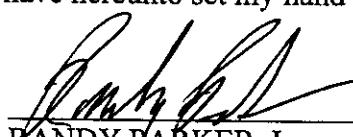

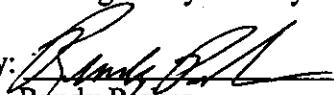
