We the undersigned residents of the State of Idaho, all of 11 MWhom are full age citizens of the United States of America, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.

ARTICLE I

NAME AND LOCATION

The name of the corporation shall be SUNRISE TERRACE HOMEOWNER'S ASSOCIATION, INC. and its principle place of business shall be in the Sunrise Terrace subdivision, city of Sagle, County of Bonner, State of Idaho.

DURATION S

The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE III

GENERAL PURPOSES

To own and operate the presently existing domestic water system; and in addition, to own, by purchase or otherwise, lease, rent, or in any manner lawfully acquire, and to sell, rent, lease, or assign to any other person, firm, corporation, county, or municipality, pipelines, wells, and mains for the transportation, delivery, and sale of water; to construct, build, maintain, and operate the same; to buy and sell water and water rights from and to individuals, firms, corporations, counties or municipalites; to own , operate, maintain, and control such meters and other appliances as may be necessary in conducting its business, and to buy, own, sell, lease, or rent all such property, real, personal, or mixed, if any be necessary in the conduct of its business and not contrary to law.

To impose the restrictions, conditions, and covenents as set forth in the restrictive covenants for the plat of Sunrise Terrace.

ARTICLE IV

NONSTOCK CORPORATION

This corporation shall be nonstock, and no dividends or pecunary profits shall be declared or paid to the members thereof.

ARTICLE V

MANAGEMENT

The management of the affairs of the corporation shall be vested in its members. There shall be a board of directors and officers whose authority, election, and duties shall be granted in the bylaws, which may include that the board of directors be permitted to amend the bylaws.
