ARTICLE OF INCORPORATION

OF

FOSTER HEATING SERVICE CO.

KNOW ALL MEN BY THESE PRESENTS: that we, the undersigned, have this day associated ourselves together for the purpose of forming a corporation under the laws of the state of Idaho and to that end hereby adopt Articles of Incorporation as follows:

ARTICLE I.

The Name of the proposed corporation is FOSTER HEATING SERVICE CO.

ARTICLE II.

The purposes of the corporation are as follows:

(1) To own, manage and operate, purchase, acquire, lease, sell, mortgage, hypothecate and otherwise deal in a general sales and service business and to contract for and otherwise deal in the sale of heating and plumbing installations and repair services of all kinds and types and to deal at wholesale and at retail in all types of heating and plumbing appliances, conduits, tools, accessories and other commodities used in or associated with the heating, plumbing, construction and allied services field; also to purchase, own, lease and otherwise acquire and hold real property, buildings and all types of personal property used in or in any way associated with the operation of said general plumbing, heating, appliances and sales and services business.

(2) To take, buy, exchange, lease, or otherwise acquire real property and any interest or right therein; and to hold, own, operate, and manage real property; including business buildings, offices, mills, shops, factories, and other types of income-producing property which may at any time be necessary, useful, or advantageous for the purposes of this corporation; and to sell, exchange, lease, mortgage or pledge said properties or interests therein as may from time to time be necessary, useful or advantageous for the purposes of this corporation.

(3) To subscribe for, acquire by purchase, or otherwise, and to own, hold, sell, assign, and transfer shares of the capital stock of any other corporation and to exercise all the rights of a stockholder; to acquire by purchase or otherwise hold and dispose of the stock and bonds of this corporation.

(4) To loan money at interest and to acquire and hold notes and mortgages and other forms of securities and to sell and otherwise deal in said securities.

(5) To engage in any business whatsoever, either as principal or as agent or both, or as a syndicate, which the corporation may deem convenient or proper in furtherance of any of the purposes hereinabove mentioned or otherwise; to conduct its business in this state, in other states, in the District of Columbia, in the territories and possessions of the United States, and in foreign countries; and to have and to exercise all powers authorized by the laws of the state of Idaho under which the corporation is formed, whether expressly set forth in this article or not, as such laws are now in effect or may at any time hereafter be amended.

ARTICLE III.

The duration of the corporation is perpetual.

ARTICLE IV.

The location and post office address of the corporation is: 2704 Broadway Avenue, Boise, Idaho, but said business address may be changed from time to time by resolution of the board of directors of the corporation.

ARTICLE V.

The authorized capital stock of the corporation is \$50,000, represented by 50,000 shares of common non-assessable stock of a par value of \$1.00 per share.

ARTICLE VI.

The name and post office address of each of the incorporators and the number of shares of stock subscribed by them are as follows:

ARTICLE VII.

The capital stock of the corporation shall be non-assessable. The corporation shall have the power to purchase its own stock in accordance with the laws of the state of Idaho as are now in effect or may hereinafter be enacted.

ARTICLE VIII.

The method and manner of holding directors' meetings and stockholders' meetings, the authority and duties of each of the officers of the corporation, and all other matters for management and control of the corporation shall be determined by the By-Laws of the corporation and by the laws of the state of Idaho.

ARTICLE IX.

These articles may be amended in any respect conformable to the laws of the state of Idaho by a vote of the required percentage of stockholders as required by the laws of the state of Idaho, at a meeting of stockholders called for that purpose as prescribed by law.
