

ARTICLES OF INCORPORATION
OF THE
WESTERN STAR BIG CREEK MINING COMPANY.

KNOW ALL MENBY THESE PRESENTS: That we, George W. Sparenberg, Hulda Loeber, Salvator Teichie, Herman J. Rossi, Thad C. Riddle, all citizens of the United States and residents and freeholders of Shoshone County, State of Idaho, do hereby voluntarily associate ourselves together for the purpose of forming a corporation and becoming a body corporate under the laws of the State of Idaho.

We hereby declare and set forth:

1. The name of this corporation is and shall be the WESTERN STAR BIG CREEK MINING COMPANY.

2. This corporation is formed for the purpose of locating, claiming, holding, working, developing, bonding, leasing, purchasing, owning and selling mines and mining claims, water rights, millsites, easements and all other rights, property and appurtenances pertaining to mines and mining claims; purchasing, constructing, leasing and building mills and concentrators, and all works and machinery necessary for the milling, mining, concentrating, reducing, smelting and handling of ores; locating, purchasing, owning, bonding, leasing and renting and selling other real estate and personal property; and engaging in a mercantile business, and buying and selling goods, wares and merchandise and other personal property, and establishing, owning, conducting, operating and maintaining boarding and lodging houses and stores in connection with mining operations and otherwise.

3. The office and principal place of business of this corporation shall be in the City of Wallace, County of Shoshone, State of Idaho.

4. The corporation shall exist fifty years.

5. There shall be six directors, who shall constitute the board of directors. The names and residence of those who are selected and appointed for the first year are as follows: George W. Sparenberg, Hulda Loeber, Salvator Teichie, of the City of Wardner; and Herman J. Rossi, Thad C. Riddle and S.P. Fairweather of Wallace, Idaho.

6. The capital stock of this corporation shall be one million dollars, divided into one million shares of the par value of one dollar each, all of which is fully subscribed and paid by the following named incorporators:

George W. Sparenberg,	749,800 shares;
Salvator Teichie,	155,250 shares;
Hulda Loeber,	93,750 shares;
Herman J. Rossi,	1,000 shares;
Thad C. Riddle,	100 shares;
S.P. Fairweather,	100 shares.
