ARTICLES OF INCORPORATION

OF THE

ADAIRAIR, INC.

WE, the undersigned, all of whom are natural persons, of the age of 21 years or more and citizens and residents of the United States, hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and for such purpose we hereby make, execute and adopt the following articles of incorporation:

ARTICLE I.

The name of this corporation shall be "Adairair, Inc."

ARTICLE II.

The objects and purposes of this corporation shall be:

1. To engage in a flying business including the ownership, leasing, rental, sale and charter of airplanes and accessories.
2. To acquire by purchase, exchange, construction, or other means, and own, lease, and maintain buildings and structures;
3. To lease lands, to purchase and acquire lands, real estate and chattels for the purposes of this corporation, and to acquire, sell, mortgage, lease, or otherwise dispose of all real or personal property necessary and convenient to such business;
4. To hire and contract all necessary labor in connection with or convenient to such business;
5. To purchase, acquire, hold, and dispose of the stocks, bonds, and other evidences of indebtedness of other corporations

and the obligations of private persons and business combinations;

6. And to generally do all those acts convenient or necessary to the business of this corporation, or conducive or helpful thereto, directly or indirectly.

ARTICLE III.

The duration of this corporation is unlimited.

ARTICLE IV.

The location and post office address of the registered office of this corporation in this state is: 609 Burrell, Lewiston, Idaho, 83501.

ARTICLE V.

The business and prudential affairs of this corporation shall be managed and controlled by a board of directors consisting of not less than three nor more than five, the number to be decided and the selection thereof to be made at the annual meeting of the corporation each year for the year then beginning. The number of directors for the first year and until the first annual meeting of this corporation shall be three, unless the board of directors shall appoint additional directors to hold office during such year and before the first annual meeting of such corporation.
