

ARTICLES OF INCORPORATION
OF THE
IDAHO AND EASTERN RAILWAY COMPANY.

-O-O-O-O-O-O-

We, the undersigned, all bona fide residents of the State of Idaho, under and in pursuance of the laws of said State, do hereby associate ourselves together for the purpose of creating a corporation with power to construct and own a railroad and franchises as hereinafter provided and do hereby agree to and adopt the following:

ARTICLES OF INCORPORATION.

I.

The name of this corporation is the Idaho and Eastern Railway Company.

II.

The purpose for which this corporation is organized is to construct, own, maintain and operate a railroad line, to be operated by steam or electricity, or both, or such other motive power as shall at a later time be deemed advisable, with such branch lines and extensions as may from time to time be deemed desirable and as may be authorized by law.

The said railroad line is intended to be run from a point in or near the city of Boise, Ada County, Idaho and extending thence up Boise River to the mouth of Moore's Creek, thence up Moore's and Grimes Creeks to a point on the divide between the headwaters of Grimes Creek and the South fork of the Payette River in the vicinity of Grimes Pass; with a branch line from the place of junction of Grimes and Moore's Creeks thence up Moore's Creek to the divide between Moore's Creek and Crooked River; also a branch up Granite Creek from its mouth to the divide between the headwaters of Granite Creek and the Payette River; also a branch up the Boise River above the mouth of Moore's

Creek to the junction of the North and Middle Forks of the Boise River.

The total estimated length of said railroad line and branches is One Hundred Twenty-five (125) miles and the same will be situated within the Counties of Ada, Elmore and Boise in the State of Idaho.

III.

The place where its principal business is to be transacted shall be Boise, Ada County, State of Idaho.

IV.

There shall be the following officers of this corporation, to-wit, a President, a Vice President and a Secretary- Treasurer, and the following are the names and residences of the directors and other officers of the corporation who are hereby appointed for the first year and until their successors are duly elected and qualified:

V.

The term for which it is to exist is fifty (50) years from and after the date of its incorporation.

VI.

The number of its directors shall be five, one of whom shall be a resident of the State of Idaho.

VII.

The stockholders shall not be individually liable for the debts of this corporation.

VIII.

The amount of the capital stock shall be \$1,500,000, divided into 15,000 shares of the par value of \$100.

IX.

The full amount of said capital stock has been actually subscribed and the following are the names of the persons by whom the same has been subscribed, to-wit:
