
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

The undersigned hereby states the following to form a corporation under the laws of the State of Idaho.

1. The name of the corporation is Allen's Trucking, Inc.
2. The corporation shall have perpetual duration.
3. The purpose of the corporation is the transaction of all lawful business.
4. The corporation shall have the authority to issue ten thousand (10,000) shares of its common stock having \$1.00 par value each. Each share of stock owned by an individual shareholder may not be transferred to any other person or entity without first offering it to the other shareholders of the corporation at the same price for a period of thirty (30) days.
5. The address of the registered office of the corporation is 56 South State Road, Malad, Idaho 83252.
