	The reason and need for the Dissolution of the corporation is: This non-profit corporation was formed in ERROR on November 17, 2005 by the seated members of the Board for the Mellen Subdivision Water District (District). This District is, was and shall always be a governmental unit; not a private entity.	
	There are no documents within the District's files that explain why that Board chose to file Articles of Incorporation. Three of the original application signors were contacted by the District's Administrative Services not one was able to offer any explanation or reason for the incorporation; it was filed in error.	
	The error is simply that the District is a political subdivision Taxing District of the State of Idaho formed under Idaho State Statute Title 42, Chapter 32 by the District Court of the Fourth Judicial District of the State of Idaho, In and For the County of Elmore entered the Order Organizing District Case#12420 on November 13, 1991 and as such should not have incorporated.  The designation entered under Article #8 on the original application stating that upon dissolution of this incorporation the assets shall be distributed to "subscribers of this district" is absolutely wrong. The assets of the District belong solely to the governmental unit, the District, until such time as the District is dissolved pursuant to Idaho State Statue Title 42, Chapter 32.
