

Articles of Incorporation
of the
CLEARWATER SHORT LINE RAILWAY COMPANY.

KNOW ALL MEN BY THESE PRESENTS: That the undersigned whose names are subscribed hereto, do by these presents, associate themselves together for the purpose of forming a corporation under the laws of the State of Montana, and to that end make and adopt the following Articles of Incorporation.

Article I.

The name of the corporation is "CLEARWATER SHORT LINE RAILWAY COMPANY."

Article II.

The purpose for which this corporation is formed, is the construction, maintenance and operation of a railroad and a telegraph line in connection therewith.

Article III.

The place where the principal business of said Company is to be transacted is ^{City} Helena, Lewis & Clarke County, State of Montana.

Article IV.

The term for which said corporation is to exist is twenty (20) years from and after the date of these articles.

Article V.

The number of directors of said corporation is seven (7) and the names and residences of the first board of directors, who are appointed hereby for the first three months, and until their successors are elected and qualified, are O. S. Nellen, J. W. Kendrick, C. W. Bunn, each of St. Paul,

Minnesota, and Mr. Wallace, Jr., A. D. Edgar, and Harry Yaeger
and Geo. A. Kiper each of Belgrade, Montana/

Article VI.

The amount of the capital stock of said corporation is Ten Thousand Dollars (\$10,000.00) to be divided into One Hundred (100) shares of One Hundred Dollars each. Said amount of stock is necessary for the construction of said railroad and telegraph line.

Article VII.

The full amount of the capital stock of said corporation has been actually subscribed by the following persons in the following amounts each respectively: C. S. Nellen, Nine Thousand Four Hundred Dollars (\$9400.00); J. W. Hendrick, One Hundred Dollars (\$100.00); G. V. Davis, One Hundred Dollars (\$100.00); Mr. Wallace Jr., One Hundred Dollars (\$100.00) A. D. Edgar, One Hundred Dollars (\$100.00); Harry Yaeger, One Hundred Dollars (\$100.00); and Geo. A. Kiper, One Hundred Dollars (\$100.00).

Article VIII.

The western terminus of said road is located on the South side of the Snake River, near the junction of that River with the Columbia River, in the vicinity of the town of Aspworth, County of Walla Walla, and state of Washington, United States of America; and the eastern terminus in the vicinity of the City of Missoula, in the western County of Missoula, State of Montana, United States of America.

The road is to pass through the counties of Walla Walla, Columbia, Garfield, and Asotin, in the state of Washington; through the counties of Nez Perces, Shoshone, and Idaho, in the state of Idaho; and through the county of Missoula, in the state of Montana all in the United States of America.

And its general route is from the most convenient point of connection with the main line of railroad of the Northern Pacific Railway Company, at or near the town of Almoorah aforesaid; thence Easterly and along the course of the Snake River, the Clearwater River and its tributaries; and across the Bitter Root Range of Mountains, by way of the Lo Lo pass or adjacent passes, to the most convenient point of connection on the east side of said Bitter Root Range and in the vicinity of Missoula aforesaid, with either the main line of railroad of the said Northern Pacific Railway Company, or the Bitter Root, or the Beart branches thereof.

The undersigned, Wm. Wallace, Jr. as Chairman of the Meeting of Stockholders of the CLEARWATER SHORT LINE RAILWAY COMPANY held in Helena, Montana, on the 10th day of November, A. D. 1898, for the purpose of considering the proposed increase of the Capital Stock of said Company, pursuant to the provisions of Sections 412, 413 and 414 of the Civil Code of Montana, hereby certifies that the said Sections were complied with in full; that the facts detailed in the following minutes of the said Meeting all transpired as therein stated, and that the following is an exact copy of the minutes of said Meeting, so held:

MINUTES OF STOCKHOLDERS' MEETING TO INCREASE CAPITAL STOCK.

On this 10th day of November, A. D. 1898, at a Stockholders' Meeting of CLEARWATER SHORT LINE RAILWAY COMPANY held in Helena, Montana, the Company's principal place of business, all of the Stockholders were present in person or by sufficient proxy approved in the meeting and signed in the minutes of this meeting the following written consent to its being held without the previous notice required by section 413, Civil Code of Montana, such consent being given pursuant to Section 446, Civil Code of Montana.

The undersigned, all the stockholders of the aforesaid corporation, being all present in this meeting, called for the purpose of increasing the capital stock of said Company without previous notice hereby consent and sign a written consent to this meeting without such previous notice, on the record of this meeting, and declare that all the acts and proceedings of this meeting are as valid as if had at a meeting legally called and noticed therefor.

Whereupon the meeting organized by choosing Wm. Wallace, Jr. one of the Directors as Chairman and A. D. Edgar, the Assistant Secretary of the Company, was selected as secretary of the Meeting.

Whereupon it was reported to the meeting that all of the original capital stock of this company was wholly subscribed for and paid in, and it was announced to the meeting that it was proposed to consider the question of increasing the amount of the capital stock of this corporation from Ten Thousand Dollars to Fifteen Million Dollars, divided into One Hundred and Fifty Thousand shares of the par value of One Hundred Dollars each.

And whereupon the following resolution, in writing, was presented to the Meeting and its adoption moved and seconded:

WHEREAS, the Capital Stock of this Company is Ten Thousand Dollars, divided into One Hundred shares of the par value of One Hundred Dollars; and,

WHEREAS, the power of increasing the said capital stock is by the provisions of sections 412, 413 and 414 of the Civil Code of Montana lodged in the stockholders of this Company, who are now in meeting duly assembled for that purpose:

NOW THEREFORE, pursuant to said sections, BE IT RESOLVED: THAT the Capital Stock of the CLEARWATER SHORT LINE RAILWAY COMPANY be and the same hereby is increased to Fifteen Million Dollars divided into One Hundred and Fifty thousand Shares of the par value of One Hundred Dollars each.

And the meeting proceeded to vote upon the said resolution, the vote being by the number of shares of stock, and all the stock was voted; and upon canvassing the votes it appeared that all the stock of the said company had cast votes in favor of increasing the said capital stock as aforesaid.

Whereupon said Resolution was declared carried.

And thereupon it was by resolution further duly ordered that a certificate of these proceedings, showing compliance with the provisions of this Chapter, and of sections 411 - 414 of the Civil Code, and a copy of the minutes of this meeting, also showing the amount of capital stock actually paid in of this Company, the whole amount of debts and liabilities of the Company, and the amount to which the Capital Stock was increased by this meeting, should be forthwith made out, signed and verified by the affidavit of the chairman of this meeting, and be countersigned by the secretary of this meeting, and that such certificate should be acknowledged by the Chairman and filed and recorded in the

office of the County Clerk and Recorder of the County of Lewis and Clarke, and in the office of the Secretary of State of the State of Montana, and other counties required by law.

There being no further business, on motion, the meeting adjourned after the execution, as above provided, of the certificate therein named.


