ARTICLES OF INCORPORATION

OF

FAR WEST DEVELOPMENT CO., INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of legal age, and citizens of the United States, do hereby associate ourselves together with the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to-wit!

I.

The name of the corporation shall be FAR WEST DEVELOPMENT CO., INC.

II.

The nature, objects and purposes for which this corporation is formed shall be:

- a. To purchase, acquire, through the issuance of its capital stock or otherwise, own, hold, lease, either as lessor or lessee, sell, exchange, subdivide, mortgage, deed in trust, plant, improve, cultivate, develop, construct, maintain, equip, operate, and generally deal in any and all lands, improved and unimproved, dwelling houses, apartment houses, hotels, boardinghouses, business blocks, office buildings, manufacturing works and plants, bowling alleys, recreational facilities and improvements, cafes, service stations, motels and other buildings of any kind, and the products and avails thereof, and any and all other property of any kind and every kind or description, real, personal, and mixed, wheresoever situated, and to act as agent for all persons, corporations, partnerships or associations for these purposes.
- b. To introduce, erect, operate, conduct, manage, maintain, and carry on a restaurant, cafe and cabaret business; to buy, sell, lease or otherwise dispose of, and to operate, conduct, furnish, equip and manage restaurants, inns, eating houses, tavers, cabarets, cafes or places of entertainment and generally to do and perform everything necessary for carrying out the aforesaid purposes. To buy or otherwise acquire, manufacture, market, prepare for market, sell, deal in and deal with, import and export food and food products of every class and description, fresh, canned, preserved or otherwise, and to prepare and serve all food, beverages, alcoholic or non-alcoholic, and other preparations and refreshments of all kinds.

- c. To buy and sell, manufacture and distribute, lease and otherwise deal in, at wholesale and retail, new and used automobiles, vehicles, trucks, tractors, trailers, machinery, implements, equipment, accessories, and parts, and to render services in connection with the same.
- d. To purchase, own, operate and conduct storage and parking facilities for automobiles and motor vehicles and to purchase, own and sell land, buildings, material, equipment, machinery, appliances and personal property used or to be used in the operation of storage and parking facilities for automobiles and motor vehicles.
- e. To buy, sell and deal in all kinds of contracts, notes, bills of sale, mortgages and other evidences of debt, and the security for the payment of the same; to buy and sell all forms of insurance and to act as agent for insurance companies; to discount or negotiate notes, bills and other evidence of debt; to buy, sell, own and hold shares of capital stock of other corporations, and to buy, own and hold the capital stock of the Far West Development Co., Inc.
- f. To acquire by purchase, subscription or otherwise, and to hold and hypothecate, and to dispose of stocks, bonds, or any other obligation of all kinds; and to sell, trade in and exchange the same, and all classes of stocks, bonds, notes, bills of sale and other securities.
- g. To transact the business of investing on behalf of itself or others, any part of its capital and such additional funds as it may obtain, or any interest therein, either as tenant in common or otherwise, and ælling or otherwise disposing of the same, or any part thereof, or interest therein.
- h. To purchase, improve, develop, lease, exchange, sell, dispose of, and otherwise deal in and turn to account, real estate; to purchase, lease, build, construct, erect, occupy, and manage buildings of every kind and character whatsoever; to finance the purchase, improvement, development, and construction of land and buildings belonging to or to be acquired by this company, or any other person, firm, or corporation.
- i. To buy, hold, purchase, contract for, own, sell, mort-gage, lease, or exchange real or personal property of all kinds.
- j. To carry into effect the object and purpose aforesaid, this corporation is authorized to do all and singular the things necessary and convenient to carry out the general purposes for which it is organized.
- k. All the foregoing provisions of this Article II are to be construed both as objects and powers, and it is hereby expressly provided that the enumeration herein of specific powers and objects shall not be held to limit or restrict in any manner the general purposes and powers of the corporation; provided, however, that nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business or to exercise any power or do any act which a corporation formed under the laws of the State of Idaho now or hereafter existing may not, at the time, lawfully carry on or do. It is the intention that the purpose,

objects and powers specified in each of the paragraphs of this Article II shall, except as otherwise provided, in no wise be limited or restricted by reference to or inference from the terms of any other clause or paragraph in these Articles contained or of any other provisions of this Articles of Incorporation.

III.

The duration of this corporation shall be perpetual.

IV.

The location and post office address of the registered office of the corporation is and shall be McCall, Idaho.

V.

The total authorized number of shares which may be issued by this corporation is One Hundred Shares of Common Stock with a par value of One Hundred and NO/100 (\$100.00) Dollars per share and non-assessable.

VI.

All shares of this corporation are the same class with equal rights and voting power and without preference or priority of any share over any other share.
