## Articles of Incorporation Amended and Restated of Crossroads Community Chapel of Bonners Ferry, Idaho, Inc.

### **Amended Preamble**

We, the undersigned, the amending and restating Incorporators, hereby associate ourselves together to amend, restate, form and establish a Corporation not for profit, a Christian Church, under the laws of the State of Idaho, pursuant to Title 30, Chapter 3, Idaho Code.

### **Article 1 of Incorporation Amended**

#### *Name and Location:*

The name of the corporation shall be CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC., and its location shall be 6525 Jackson Street, City of Bonners Ferry, County of Boundary, State of Idaho. The Corporation is also commonly known and sometimes does business as either or both, "Crossroads Community Chapel" or "Crossroads Chapel."

### **Article 2 of Incorporation Amended**

#### *Duration:*

The period of duration of the non-profit Corporation shall be perpetual.

### **Article 3 of Incorporation Amended**

#### *Purpose:*

CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC., is organized exclusively as a Christian Church dedicated to charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under 501 (c) (3) of the Internal Revenue Code or corresponding section of any future Federal tax code.

This Corporation shall not have authority to issue capital stock. This Corporation, pursuant to its purpose shall have the power to buy, sell, receive by gift, give and encumber personal and real property.

The CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC., objectives, business and purpose is both nonpolitical and nonprofit. The organization is devoted to the promotion of the Gospel of Jesus Christ, the teaching of the Bible, the elevation and maintenance of both private and public morality, and the advancement of Christian fellowship and mutual spiritual support.

CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC., is evangelical in its beliefs, missionary in endeavor, cooperative in spirit with other Christian bodies, Wesleyan/Arminian in its theological perspective and episcopal in its organization.

We mean by independent and non-denominational that CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC., is a sovereign self-governing fellowship of believers. We mean by evangelical that CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC., is a Protestant ministry, emphasizing salvation by faith in the atoning death of Jesus Christ through personal conversion, the authority of the Bible, and the importance of Biblical and therefore Christ-centered preaching, evangelism and discipleship.

We mean by missionary that CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC., is committed to the evangelization of the entire world.

We mean by cooperative that CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO INC., does not withdraw itself from other Christian groups. The largeness of the undertaking and the brevity of opportunity compel us to cooperate with other Bible-believing Christians.

We mean by Wesleyan/Arminian that our roots are in the soil of primitive Bible-believing Methodism as founded by John and Charles Wesley.

We mean by episcopal that our organization is principally appointive.

#### **Article 4 of Incorporation Amended**

##### *Membership, Annual Covenant, General Beliefs*

###### **Membership**

This Corporation shall have non-voting members who voluntarily together yearly make an Annual Mutual Covenant of association to one another in Christian fellowship and service. The conditions of the Covenant as well as regulations of membership and the rights and other privileges of the Covenanters i.e., the members, and attendees shall be fixed by the Corporation's By-Laws.

###### **The Annual Covenant**

"Today I happily testify that by faith, I know and experience Jesus Christ as my Savior and Lord.

Today, with faith in God's enabling power, I renounce the Devil and all his works, the empty pretense and glory of this fallen world, and embrace the Cross and follow Christ.

Today I openly confess my firm belief in God the Father Almighty, Maker of heaven and earth; and in Jesus Christ His only Son our Lord; that He was conceived by the Holy Spirit, born of the Virgin Mary, that He suffered under Pontius Pilate, was crucified, dead and buried, that the third day He arose from the dead; that He ascended into heaven, and is sitting at the right hand of God the Father Almighty; and from there He shall come to judge the living and the dead. I believe in the Holy Spirit, the Christian Church, the communion of saints, the forgiveness of sins, the resurrection of the body and life everlasting.

Today I Affirm I have, or will at the first opportunity, publicly acknowledge my New Birth in Christ by water Baptism and my continued dependence upon Christ by the receiving of Holy Communion.

Today I Covenant, God being my helper, to seek God's Will, Kingdom and Righteousness and therein surrender to the Holy Spirit so that His Fruits of love, joy, peace, long-suffering, gentleness, goodness, faith, meekness and temperance, may be manifest in my life.

Today I Covenant to be resolute and faithful to the congregation and leadership of Crossroads Community Chapel, and to encourage my Crossroads Family with my love, kindness, cooperative spirit, presence, prayers, tithe, and service.

Today I Covenant to acknowledge and to be guided by our General and Particular Statements of Belief, and our Constitution and By-Laws and thereby ensure a lasting work, to the safeguarding of the investment of our lives and the provision for our hopes for the days ahead.

With firm reliance on God's Providence, all this we now willingly and humbly Covenant, in the Name of the Father and of the Son and of the Holy Spirit."

###### **General Beliefs**

1. The Bible is the only infallible, inspired, authoritative Word of God;
2. That there is only one God, who eternally exists in Three Persons: the Father, the Son and the Holy Spirit, The Trinity;
3. In the Deity of Jesus Christ, His virgin birth, His sinless life, His miracles, His bodily resurrection, His ascension to the Father, and His personal return to earth in power and glory;
4. That God has provided forgiveness for all men only through the death of Jesus Christ and that through faith in Him anyone may experience a new life;
5. In the present ministry of the Holy Spirit and that through His indwelling and infilling the believer is able to live a holy life on earth;
6. In the resurrection of both the saved and the lost; they that are saved to eternal life and they that are lost to eternal damnation;
7. In the spiritual unity of believers in Jesus Christ.

More particular tenets of Doctrine shall be fixed by the Corporation's Statement of Belief. The General and Particular Statements of Faith of Crossroads Community Chapel of

Bonnerr's Ferry, Idaho, Inc., shall not be amended except for the purpose of a further exegesis and clarification of the original Articles of Faith of the Founding Incorporating Pastor's Council and the Founding Pastor.

#### **Article 5 of Incorporation Amended**

##### ***Board of Directors, Meetings, Agendas and Prohibition of Compensation:***

The affairs of this Corporation shall be managed by a Board of Directors, designated "the Pastor's Council." The Pastor's Council, i.e., The Board of Directors, shall meet bi-monthly and shall deliberate on items listed on a prepared written agenda in accordance with the By-Laws of the Corporation. Further responsibilities and membership qualifications of the Pastor's Council shall be determined and fixed by the By-Laws of this Corporation.

No part of the net earnings of CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC., shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

#### **Article 6 of Incorporation Amended**

#### **Article 7 of Incorporation Amended**

##### ***Prohibited Activities:***

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future Federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

#### **Incorporation Articles Amended to include Article 8**

##### ***Dissolution:***

Upon a dissolution of CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC., The Corporation shall distribute all remaining assets as follows:

First, before final dissolution, pay all Corporate liabilities and fulfill all Corporate responsibilities including any employee pensions.

Second, Upon the final dissolution of the Corporation, all remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal Government, or to a State or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the District Court of the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes. The Incorporators prefer

that receiving 501 (c) (3) Corporations conform with the historic Wesleyan/Arminian Christian theological perspective of the founders of CROSSROADS COMMUNITY CHAPEL OF BONNERS FERRY, IDAHO, INC.

### **Incorporation Articles Amended to include Article 9**

#### *Amendments to Incorporation*

Incorporation provisions may be amended, altered, or repealed as follows:

1. A written proposal of an amendment may originate from the Senior Pastor or to and through him from any Covenanter.
2. No amendment shall be adopted without the written approval and recommendation of the Senior Pastor. No amendment shall be made to our Corporation provisions that, as far as is practical, voids in general terms the original intent of the Founding Incorporating Pastor's Council.
3. After recommendation by the Senior Pastor, followed by the prayerful deliberation by the Pastor's Council and after their initial approval, any proposed Amendment shall be tabled with expectation of final approval for a period of at least 120 days, until a regularly scheduled bi-monthly Council meeting. After 120 days and a second approval by the Senior Pastor and the Pastor's Council the proposed amendment shall be adopted and the amendment filed with the Secretary of State of the State of Idaho.

### **Articles of Incorporation Amended to include Article 10**

#### *By-Laws*

The Pastor's Council, acting as the Board of Directors of this Cooperation shall have the sole power to adopt, alter, amend or repeal the By-Laws of the Corporation which may contain any provision or regulation for the management of the affairs of the Corporation not inconsistent with the laws of the State of Idaho, or the Articles of Incorporation.

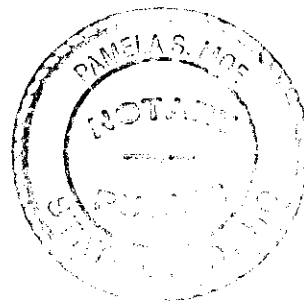

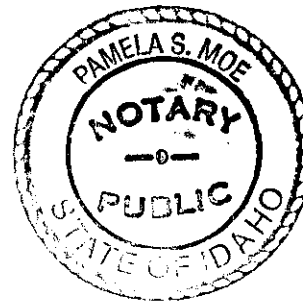

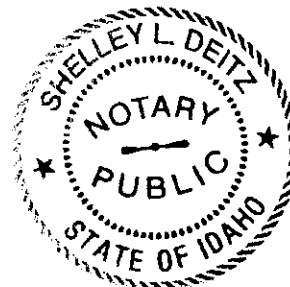
