ARTICLES OF INCORPORATION

OF

SEMPA, INC.

The undersigned, acting as the incorporator of a corporation (hereinafter referred to as the "Corporation"), pursuant to the Idaho Business Corporation Act, Idaho Code, §§30-1, et seq., adopts the following Articles of incorporation for the Corporation.

ARTICLE I

The name of the corporation is SEMPA, INC..

ARTICLE II

The period of duration of this corporation is perpetual.

ARTICLE III

The purposes for which the corporation is organized are as follows:

A. To assist stock purchases in Micron Technology, Inc. of common stock by certain employees of J. R. Simplot Company.

B. To exercise all powers granted by law necessary and proper to carry out the above-stated purposes, including but not limited to the power to borrow money and loan money and to accept donations of money, property, whether real or personal, or any other thing of value.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 1,000 common shares, each having a par value of one (\$1.00). The holders of the common stock shall be entitled to receive, when and as declared by the Board of Directors, as permitted by the Act, dividends or distributions payable either in cash, in property, or in shares of the capital stock of the corporation. Each shareholder of record shall have one (1) vote for each share of stock standing in his name on the books of the corporation.

ARTICLE V

The business and affairs of the corporation shall be managed by the Board of Directors. The Board shall consist of three (3) individuals who may elect successor directors. The officers of the corporation shall be chosen by the Board of Directors from among the Directors. The officers of the corporation shall be chosen by the Board of Directors from among the Directors. The officers shall consist of the Chairman, a Vice-Chairman, a Secretary and Treasurer. Elections shall be held annually, the date and place to be fixed by the Board of Directors. All procedures shall be set forth in the Bylaws of the corporation.

ARTICLE VI

The number of directors of the corporation shall be as specified in the Bylaws. Three (3) directors shall constitute the initial board, their names and addresses being as follows:
