ARTICLES OF AMENDMENT TO

THE ARTICLES OF INCORPORATION OF

BIOTECHNIC CORPORATION

* * * * * * * * * * *

WHEREAS, BIOTECHNIC CORPORATION was organized under and by virtue of the laws of the State of Idaho, on the 20th day of December, 1985, and

WHEREAS, on the 26th day of August, 1986, upon proceedings duly had, the Articles of Incorporation of said corporation were amended to change the name of the Corporation from BIOTECHNIC CORPORATION to BIOTECHNIQUE CORPORATION.

NOW, THEREFORE, I, the undersigned, being the sole incorporator, and President of Biotechnic Corporation, adopted the resolution as set out below, at a special meeting which was held at the law offices of Paul T. Smith, 136 Sixth Avenue North, Twin Falls, Idaho, on the 26th day of August, 1986:

"RESOLVED, That Article I of the Articles of Incorporation of Biotechnic Corporation be amended to read as follows:

"ARTICLE I

"The name of the corporation is Biotechnique Corporation."

That no shares of stock of the Corporation have been issued, and such sole incorporator, by a his single vote "Yes," duly passed and adopted the foregoing resolution as stated above.
